REPORT OF CHURCH COUNCIL MEETING

Thursday evening, September 8, following our monthly unit meeting the members of the Church of the Brethren met together for Church Council meeting which convenes every quarter.

The treasurer, Chester Peckover, reported that in addition to the incidental cash on hand, we have \$145.71 in our Building Fund and \$75.00 in our Social Service Fund. For more than a year we have set aside twenty-five percent of our offerings for a building fund,

The following action was taken by the Church Council:

- 1. The church is to furnish the Academy with the necessary Spanish Bibles for its Bible classes.
- 2. That we should substitue our Spanish Prayer Meetings for services in English. Another hour is to be set aside for Spanish Prayer Meeting. (Note: Dr. Burke is to have charge of these Spanish services.)
- 3. That weekly church bulletins be prepared by the pastor for distribution to those in the hospital, to the community, and to other interested persons. The church is to pay one-half the cost of a duplicator and the other half is to come out of the Religious Life Fund.

- 4. A Communion Service is to be held on World Communion Sunday, October 2.

At the last Unit Meeting, it was decided that the Unit Religious Life Committee should be in charge of all the English religious services with the exception of the Communion Services. At this meeting, it was also decided to place more emphasis on the dining hall devotions and to have more of them orally. Barbara Hershberger was chosen to be in charge of the dining hall devotions.

The unit chose the following officers for the services in English:

A special meeting of the Church Council was called on Sunday evening, September 25. It was decided that twenty folding chairs would be purchased for the church, half the money coming from the Building Fund and the other half from the cash on hand.

Due to the absence of the wives of the official board a committee of three was chosen to prepare the food for communion. These were Martha Rupel, Fern Troche, and Lila Peckover.

THE BIG WIND OF SEPTEMBER TWENTY-SECOND

Every year in Puerto Rico we have what is known as the hurricane season. During this season, which generally runs from August to October, there is always the possibility that any of the tropical disturbances which originate in this area may pass over the island. From the time of the first report of a tropical disturbance until the storm either hits or misses, we anxiously await reports on its progress over the radio.

Around noon on Wednesday, September 21, we heard the first report of one of these tropical disturbances. In a later report during the afternoon we discover-



ed that Castaner would be included in the hurricane precaution area. By six o'clock that evening everyone was busy boarding up all the openings in the buildings around the project and getting prepared for a night of heavy wind and rain. As was expected the lights refushed to cooperate anymore after 5:40 p.m. and the kerosene lamps and candles were hauled out.

From about midnight on until early Thursday morning we had strong winds and a heavy rainfall.

Daylight Thursday morning found a let-up of the storm and we were able to see the damage which had occurred during the night. No buildings were damaged but fruit trees and gardens were hit hard. Many banana trees were blown over and oranges

and avocados were stripped from the trees. After this experience, we are all very happy that we are somewhat protected from heavy damage by the surrounding mountains and are definitely not looking forward to any similar experience in the future.

We all like their new home very much. It is conveniently located just below the hospital and it is only a three or four minute walk up the hill.


UNIT PARTIES
